## Amy and Annie Eagen

The 1892 West Kootenay tax assessment (held by Kootenay Lake archives) lists Miss Annie Egan as owner of property 165, a home in New Denver at Lot 10, Block 13. Today this is apparently a vacant lot with trees owned by Anne Uphill. M. Egan owned property 166, also a home in New Denver, at Lot 5, Block 14.

The 1901 census lists Annie and Mamie Eagan, mother and daughter. Annie was born 6 Jan 1850 in Ireland and arrived in Canada in 1895. Mamie was born in 15 Aug 1877 in the US. Annie was listed as running a 'lodging house' (i.e. a hotel) while no profession was listed for Mamie.

The Ledge, 27 Dec 1894: Lucky winners

Two raffles were held at the Hotel Slocan on Monday afternoon ... The other raffle was for a crayon picture, entitled The Bunnies, the property of Miss Egan, of Three Forks.

The Ledge, 20 Jun 1895: Mrs. Bowen and Miss Egan of Three Forks and Mrs. Capt. Moore of the concentrator, spent Saturday in the metropolis.

*The Paystreak*, 26 Sept 1896: Mrs. Eagan's lodging house ready in a few days.

*The Paystreak*, 17 Apr 1897: Mrs. Egan contributes \$2.50 to fire department subscription.

*The Paystreak*, 17 Jul 1897: Miss Mamie Egan is very sick with typhoid fever.

*Mining Review*, 21 Aug 1897: Annie Egan was among three women who signed the petition to incorporate Sandon.

Mining Review, 2 Oct 1897: Harris, Miss Egan, and several others go to the Spokane fruit fair.

Mining Review, 23 Oct 1897 (I think): Miner injured at the Reco brought to Mrs. Egan's where he is under treatment (no hospital yet).

*Mining Review*, 29 Jan 1898: Miss Egan was visiting Three Forks last week.

Mining Review, 5 Mar 1898: Mrs. Egan returns from Dakota, where she disposed of property.

*Mining Review*, 1 Oct 1898: Miss Egan attends Spokane fruit fair.

*Mining Review*, 17 Dec 1898: Mrs. Wilmot of Spokane in town visiting Miss Egan.

*Mining Review*, 25 Mar 1899: Miss Egan leaves on pleasure trip to Spokane and other points.

The Paystreak, 9 Sept 1899: Mrs. Egan leaves for a three-month visit to Philadelphia.

Mining Review, 9 Sept 1899: Mrs. Egan to take trip to Pennsylvania, where her daughter is visiting.

*Mining Review*, 11 Nov 1899: Mrs. Egan returns from Philadelphia, where she had been visiting her daughter.

*Mining Review*, 24 Mar 1900: Miss Egan returns from Philadelphia, where she had been taking an art course.

Letter from Gilbert Malcolm Sproat to J.M. Harris, 14 Jun 1900, held by University of B.C. special collections, Harris fonds, Box 1, File 3: "I note what you say as to Mrs. Egan, but with all due respect to that lady, as she is over 24, I would rather have nothing to do with her. Even when under that age I generally get left, although a reasonably gay old bird, manage [?] the grippe."

The Paystreak, 16 Jun 1900: License transferred from Walmsley and Bennett, Palace Hotel, to Mrs. Annie Egan

*The Paystreak*, 23 Jun 1900: Mrs. Egan will build a three-storey hotel ... on the lower skating rink lot.

*Mining Review*, 23 Jun 1900: Mrs. Egan is on the skating rink site for a new three-storey Palace.

*The Paystreak*, 7 Jul 1900: Mrs. Egan foundation nearly complete.

Mining Review, 7 Jul 1900: Mrs. Egan has returned from Spokane and she and Mr. Egan will likely take up their residence at the Ivanhoe concentrator.

The Paystreak, 14 Jul 1900: Mrs. Egan's hotel going up in a rush.

*Mining Review*, 14 Jul 1900: Mrs. Egan's three-story hotel reaching skywards.

*Mining Review,* 11 Aug 1900: Mrs. Egan to open the new hotel in a few days.

*Mining Review*, 29 Sept 1900: Mrs. Egan has built addition to her hotel.

John Morgan Harris fonds, UBC special collections, Box 3, File 3 contains a Hotel Reco billhead "in account with Mrs. A. Eagen," 29 Sept 1900.

The Paystreak, 13 Oct 1900: P.L. Egan and wife visit Nelson.

Mining Review, 1 Dec 1900: Palace opens restaurant.

Mining Review, 5 Jan 1901: Gordon Sutherland superintended the erection of Mrs. Egan's hotel, 26 x 50, 3 storeys and basement, costing \$3,000.

Mining Review, 6 Jul 1901: A wedding took place on Monday afternoon in the Catholic church, where Josephs Sells, of this city and Miss Elizabeth Waggoner, of Spokane were united in marriage. J.G. McDonald acted as best man, and Miss M. Egan as bridesmaid.

*The Paystreak,* 12 Apr 1902: The Misses Carey of Nelson are visiting with Miss Egan.

The Paystreak, 7 Jun 1902: "Mrs. Eagan and her daughter left on Wednesday for Wallhalla, North Dakota." Walhalla has a pop. of 1,000 or so today.

Mining Review, 7 Jun 1902: "Mrs. and Miss Egan left Wednesday morning for North Dakota, where they will make a prolonged stay. Mrs. Egan has leased her building to Archie Philmore and J. Gordon, both favorably known in the city. They will convert the place into a hotel." Thought it already was a hotel.

Sandon city records at provincial archives: Mrs. A. Egan assessment appealed by her agent and attorney, J.M. Harris, 4 Jul 1912. Didn't say where she was living.

The Daily News (Nelson), 15 Jul 1913: "Mrs. Egan and daughter, who are old-timers in Sandon, are here. Mrs. Egan owns the Palace hotel which she has rented to A. McGillivray."

John Morgan Harris fonds, UBC special collections, Box 1, File 5 contain a Bank of Montreal cheque made out to Miss Mamie Eagan for \$90, signed by Harris, and dated 17 Jun 1915. The reverse says "Paid to British American Trust Co., Vancouver." Signed by Mamie Eagan (note spelling), 22 Jun 1915.

Vancouver Daily World, 7 Oct 1916: The Sandon Red Cross Auxiliary have forwarded a further contribution of \$100.25 per Mrs. John W. Reid and Mrs. J.M. Harris.
